TNEB – Pensioners Health Fund Scheme – Extension of Scheme to the Family Pensioners – Orders – Issued.

PROCEEDINGS:

Based on the orders of the Government, orders have been issued in the Board Proceedings first read above introducing the TNEB Pensioners Health Fund to the Pensioners of TNEB. In the Proceedings second read above, following the orders of the Government, the said Scheme was extended to the Family Pensioners of TANGEDCO (Erstwhile TNEB) based on their willingness/option of the Family Pensioners within a period of nine months from the date of issue of the order. It was also been ordered therein that if no such option is received from the existing Family Pensioners on or before the prescribed time limit, it will be construed that they are not willing to enroll themselves under the scheme. The said period was also subsequently extended upto 31.01.2014. Now, the Pensioners' Association have requested that TNEB Pensioners Health Fund Scheme may be extended to the Family Pensioners of TANGEDCO. The same has been considered.

2. Accordingly it is hereby ordered that;

- (i) The Tamil Nadu Electricity Board Pensioners Health Fund Scheme be extended to the future family pensioners of Tamil Nadu Generation and Distribution Corporation Limited, Tamil Nadu Transmission Corporation Limited and Tamil Nadu Electricity Board Limited and a monthly subscription of Rs.100/- be deducted from the Family Pension payable to them.
- (ii) All the existing family pensioners who are willing to contribute a sum of Rs.100/- per month to the fund which will be deducted from their monthly family pension till their death/till the payment of Family pension ceases, shall exercise option to the Chief Internal Audit Officer/Board Office Audit Branch, within six months from the date of issue of this order, to deduct a sum of Rs.100/- from their family pension towards contribution to Tamil Nadu Electricity Board Pensioners Health Fund Scheme.

3. The other conditions prescribed in the proceedings read above in this regard remain unaltered.
4. Receipt of this proceedings shall be acknowledged.
